**The Iowa Certified Construction Site Pollution Prevention Inspector (ICCSPPPI) training is an affordable, efficient certification opportunity for construction site inspectors who are responsible for weekly construction site or quarterly MS-4 inspections. *This course has been merged with the Iowa Certified Installer of Construction Site Pollution Prevention Practices (ICICSP3) training program.***

### **Program Topics**

- Erosion process, soils and basic hydrology
- General Permit #2 regulatory requirements
- On-site required documents
- Best management practices for erosion, sediment, velocity control, and good housekeeping
- Stormwater Pollution Prevention Plans (SWPPPs)
- Site inspection procedures
- Issues an inspector may face

### **Certification Process**

Attend ICCSPPI training, pass the written exam and sign the Code of Ethics to become certified. Those that are certified are recognized statewide for their credentials to conduct pollution prevention inspections at construction sites. Your name will also be added to the Certified ICCSPPI database located at [IowaStormwater.org](http://IowaStormwater.org).

### **The Recertification Process**

The recertification process is easy, attend the first half of an ICCSPPI training event every 3 years to remain in good standing with the ICCSPPI Program (No exam).

### **Cancellation Policy**
